The fact that you have an alarm for which a permit is required by the City of Pomona and one where a permit is on file with the Police Department is not in any manner, meant to guarantee protection by the Pomona Police Department. The issuance of such a permit is not to be construed by you, your employees, agents, or assignees as any promise to provide police response to your alarm. In the event your alarm is activated, the Police Department is notified and will take whatever action is deemed necessary under the circumstances.

The alarm system you currently have is one predicated strictly upon a contractual relationship between you and your alarm company.

The city of Pomona has a false alarm ordinance, whereby any alarm system that generates more than two (2) false alarms in any 365 day period shall have a charge assessed against the permittee when a police response occurs.

The following service fees will be charged for the third (3rd) through seventh (7th) false alarm, which includes revocation of the alarm permit;
